The Florida Engineers in Construction Professional Development Award is presented to the nominated construction employer of engineering personnel who has made the most outstanding contribution to the advancement and improvement of the engineering profession through its employment policies and practices in accord with established professional practices as outlined in Guidelines to Professional Employment for Engineers and Scientists.

The award is presented by the FECON Chairman at the Florida Engineering Society Annual Summer Conference and Exposition to an official of the organization.

The final selection for the state award will be made by the FECON Administrative Committee on the basis of both current and longtime reputation of the organizations under consideration with particular emphasis on the preceding twelve months. The factors considered are those outlined in this form.

For purposes of this program, a "construction employer" is any construction contracting firm, subcontractor, design-build or "turnkey" firm, or any subdivision of an industrial corporation whose primary function is the construction of physical facilities or structures. Excluded are organizations primarily engaged in the manufacture or supply of equipment, real estate development firms, and construction management firms where the construction function is either subcontracted or secondary to the organization's primary function.
