VII. SELECTION CRITERIA

In order to ensure an effective learning environment, the Florida Engineering Leadership Institute class size is limited to 40 individuals; therefore:

- preference will be given to candidates with at least 10 years of engineering-related experience, and
- preference will be given to members of the Florida Engineering Society (FES) or employees of firms that are members of the Florida Institute of Consulting Engineers (FICE)

VIII. TUITION

The cost of The Florida Engineering Leadership Institute is \$4,000 per participant (not including travel, lodging, and some meals), payable to Florida Engineering Society upon acceptance to the program and prior to the first session. Tuition is non-refundable.

Tuition for applicants who are not members of the Florida Engineering Society will be increased by the amount of membership enrollment, not to exceed an additional \$350 (membership dues vary based upon chapter assignment, etc.).
