The award is presented by the FECON Chairman at the Florida Engineering Society Annual Summer Conference and Exposition to an official of the organization.

The final selection for the state award will be made by the FECON Administrative Committee on the basis of both current and longtime reputation of the professional, under consideration with particular emphasis on the preceding twelve months. The factors considered are those outlined in this form.

For purposes of this program, a "professional" is any professional design engineer, program manager, field engineer, construction supervisor, public representative, or any primary function of engaging construction of physical facilities, infrastructure, or other improvements.
