HB 619: Sovereign Immunity for Professional Firms

GENERAL BILL by Tuck

Sovereign Immunity for Professional Firms; Provides that professional firms or their employees when performing specified services for certain public projects are considered agents of state or its applicable subdivision when acting within scope of their contract; requires that contracts with such firms must, to extent permitted by law, provide indemnity to state or its applicable subdivision.

GENERAL BILL by DiCeglie

Continuing Contracts; Revising the maximum estimated construction cost of construction projects for which a governmental entity may enter into a continuing contract; revising the definition of the term "continuing contract"; requiring the Department of Transportation, for specified testing continuing contracts, to select a certain number of qualified firms and assign such testing in a specified manner, etc. Effective Date: 7/1/2024

GENERAL BILL by Regulated Industries ; <u>Hooper</u>

Continuing Education Requirements; Requiring, rather than authorizing, a board, or the Department of Business and Professional Regulation when there is no board, to allow by rule that distance learning may be used to satisfy continuing education requirements; revising the requirements that such continuing education must satisfy; requiring the board, or the department when there is no board, to exempt certain individuals from completing their continuing education requirements; authorizing the department to adopt emergency rules, etc. Effective Date: 7/1/2024

HB 497: Continuing Education Requirements

GENERAL BILL by Melo

Continuing Education Requirements; Requires, rather than authorizes, board, or DBPR when there is no board, to provide by rule that distance learning may be used to satisfy continuing education requirements; revises requirements that continuing education must satisfy; requires board, or DBPR when there is no board, to exempt certain individuals from completing their continuing education requirements; requires DBPR & each affected board to adopt rules. Effective Date: 7/1/2024

HB 479: Alternative Mobility Funding Systems

GENERAL BILL by Rep. Robinson

Alternative Mobility Funding Systems; Revises requirements relating to agreements to pay for or construct certain improvements; authorizes local governments to adopt alternative mobility planning & fee system; prohibits alternative system from imposing responsibility for funding existing transportation deficiency on new development; prohibits local governments that do not issue building permits from charging for transportation impacts; prohibits local governments from assessing multiple charges for same transportation impact; revises requirements for calculation of impact fees; requires local governments transitioning to alternative funding systems to provide holders of impact fee credits with full benefit of intensity & density of prepaid credit balances as of specified date. Effective Date: 7/1/2024

SB 688: Alternative Mobility Funding Systems

House Companion Bill: HB 479

GENERAL BILL by Martin

Alternative Mobility Funding Systems; Authorizing certain local governments to adopt an alternative mobility planning and fee system or an alternative system in certain circumstances; prohibiting an alternative system from imposing responsibility for funding an existing transportation deficiency upon new development; providing that only local governments issuing building permits may charge for transportation impacts; revising requirements for the calculation of impact fees by certain local governments and special districts, etc. Effective Date: 7/1/2024

SB 472: Sovereign Immunity

GENERAL BILL by Sen. Brodeur

Sovereign Immunity; Increasing the statutory limits on liability for tort claims against the state and its agencies and subdivisions; prohibiting an insurance policy from conditioning payment of benefits on the enactment of a claim bill; specifying that the limitations in effect on the date a final judgment is entered apply to that claim, etc. Effective Date: 7/1/2024

HB 569: Suits Against the Government

Senate Companion: SB 472

GENERAL BILL by McFarland

Suits Against the Government; Abolishes common-law doctrine of home venue privilege with respect to action against state; increases statutory limits on liability for tort claims against state & its agencies & subdivisions; authorizes subdivision of state to settle claim in excess of statutory limit without further action by Legislature regardless of insurance coverage limits; prohibits insurance policy from conditioning payment of benefits on enactment of claim bill; specifies limitations in effect on date final judgment is entered apply to that claim; requires DFS to adjust limitations on tort liability every year after specified date; revises period within which certain claims must be present to certain entities; revises exceptions relating to instituting actions on tort claims against state or one of its agencies or subdivisions; revises period after which failure of certain entities to make final disposition of claim shall be deemed final denial of claim; revises limit on certain attorney fees; revises statute of limitations for tort claims against state or one of its agencies to revise state or one of its agencies or subdivisions. GENERAL BILL by Gruters

Transportation; Deleting provisions related to appointment, powers, and duties of the Florida Transportation Commission; prohibiting the designation of additional metropolitan planning organizations (M.P.O.'s) after a specified date, with an exception for certain urbanized areas; requiring each M.P.O. to report its quality performance score annually to the district secretary and to publish the score on its website, beginning on a specified date; requiring M.P.O.'s that do not achieve the minimum acceptable quality performance score within a certain timeframe to be placed under the control of the Secretary of Transportation, etc. Effective Date: 7/1/2024

HB 7049: Transportation

GENERAL BILL by Transportation & Modals Subcommittee ; McFarland

Transportation; Revises membership of certain advisory boards; revises requirements for designation of additional M.P.O.'s; revises provisions relating to M.P.O.'s long-range transportation plan & transportation improvement program; requires DOT to convene M.P.O.'s of similar size to exchange best practices; authorizes committees or working groups; requires training for new M.P.O. governing board members; requires DOT to create M.P.O. quality performance scoring mechanism; provides requirements relating to quality performance scores; removes provisions relating to Metropolitan Planning Organization Advisory Council; requires report to Governor & Legislature; requires redesign of registration license plate by DHSMV. SB 1226: Department of Transportation

GENERAL BILL by DiCeglie

Department of Transportation; Deleting the requirement that the secretary of the department appoint the department's inspector general; limiting the percentage of the total contract amount which may be allocated for the purchase of plant materials based on the monetary size of the contract; requiring each public transit provider to certify that its actual administrative costs are no greater than a certain amount; requiring the department to preserve a rail corridor within the right of way of Interstate 4 between Orlando and Tampa for a specified purpose, etc. Effective Date: 7/1/2024

HB 1301: Department of Transportation

Senate Companion: SB 1226

GENERAL BILL by Abbott

Department of Transportation; Removes provisions requiring DOT secretary to appoint inspector general; revises provisions relating to allocation of funds for purchase of plant materials, acceptance & processing of electronic payments to Florida Turnpike Enterprise, & inactive prepaid toll accounts; prohibits DOT from expending certain state funds to support certain projects or programs; authorizes DOT to enter into service contracts to finance certain projects; prohibits DOT from considering certain nonpecuniary factors when developing transportation plans; creates Supply Chain Innovation Grant Program within DOC; requires DOC & DOT to consider applications & select grant awardees; requires funds appropriated from State Transportation Trust Fund for New Starts Transit Program to revert to trust fund; revises provisions relating to public transit provider responsibilities. Effective Date: 7/1/2024
